TITLE I SCHOOL-WIDE PARENTAL ENGAGEMENT POLICY

Steelton-Highspire Jr./Sr. High School agrees to implement the following policy to encourage and promote meaningful parent involvement:

1. Steelton-Highspire Jr./Sr. High School will take the following actions to actively involve parents in the joint development of its school parental involvement policy:
 - Plan Parent Advisory Council (PAC) Meetings
 - Plan and implement Meet the Teacher Nights, as well as multiple conference sessions
 - Utilize School Social Worker and Parent Engagement Coordinators to communicate with parents who are unable to come to school functions.
 - Encourage all staff members to actively communicate with parents as a means for academic and behavioral interventions.
2. The parental involvement policy will be distributed and made available to the local community by:
 - Distribution at the beginning of each school year and with each new enrollment
 - Distribution in the main office to any school stakeholders or community members
3. Steelton-Highspire Jr./Sr. High School will convene an annual meeting, at a convenient time, to which all parents shall be invited and encouraged to attend to inform parents of their school's Title I participation, including the rights of parents to be involved. This will be accomplished by:
 - On or before November 1st of each school year
4. Steelton-Highspire Jr./Sr. High School will take the following actions to involve parents in the process of school review and improvement under ESSA, which includes the planning, review, and improvement of the Title I school wide program and activities:
 - Organize a committee of parent volunteers to work in conjunction with school administrators.
5. Steelton-Highspire Jr./Sr. High School will implement the following effective parental involvement activities to improve student academic achievement and school performance:
 - Open lines of communication with all parents
 - Open houses and conferences for parents to meet with teachers
 - Family Nights to bring families into the school building together
 - Content area activities for families
 - Rotated times for parent involvement events (morning, afternoon, evening)
6. Steelton-Highspire Jr./Sr. High School will take the following actions to conduct, with parental involvement, an annual evaluations of the content and effectiveness of this parental involvement policy in improving the quality of the school. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). Steelton-Highspire Jr./Sr. High School will use the findings of the valuation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.
 - An announced meeting for all parents on or before June 1st of each year to analyze the effectiveness of the parental involvement programs and begin to plan for the following year.

7.
